I, the undersigned Participant, acknowledge that horse-related activities, including but not limited to horseback riding, training, teaching, boarding, inspecting, evaluating, and any other equine activity as defined by the Wyoming Recreation Safety Act (W.S. 1-1-122(a)(iv)), are inherently dangerous and expose me to serious and substantial hazards and risks of property damage, physical injury, and/or death. I understand that these "inherent risks" are those dangers or conditions which are characteristic of, intrinsic to, or an integral part of any sport or recreational opportunity.

I further acknowledge that the physical environment of Silver Sage Equestrian's property may contain hazards, including, but not limited to, holes, rocks, uneven footing, slippery, muddy, or wet surfaces in arenas, round pens, pastures, or surrounding areas. I also acknowledge risks from stalls, enclosures, grooming tools, other equine equipment and tack, and tripping hazards from misplaced materials or equipment. Allergic reactions to hay or other animal-related allergens are also a possibility.

I am fully aware that participation in equine activities can result in a wide range of injuries, including but not limited to: **Soft Tissue Injuries, Bone/Joint Injuries, Head Injuries, Spinal Injuries, Internal Injuries, and Severe Outcomes.**

I also acknowledge the risk of injury or death to my horse or other horses, and damage to tack, equipment, stalls, enclosures, or personal property. I understand that no amount of care, caution, instruction, or expertise can eliminate these inherent hazards and risks. I voluntarily expose myself to these risks and their potentially serious consequences. I intend that this assumption of all risks shall be legally binding and shall be a complete bar to any and all claims by me and/or my personal representatives, heirs, next of kin, executors, administrators, assigns, and/or estate. I further covenant not to sue the Released Parties for any claim released herein.

In consideration of being allowed to enter upon the premises and participate in equine activities at Silver Sage Equestrian, LLC. I, for and on behalf of myself and any spouse, children, parents, next of kin, heirs, representatives, assigns, executors, administrators, estate, and/or any other person or entity acting on my behalf, unconditionally and irrevocably agree to forever discharge, waive, release, and hold harmless **Silver Sage Equestrian, LLC, its owners, officers, instructors, employees, volunteers, affiliates, successors, and assigns** (collectively, the "Released Parties"), from any and all claims, demands, causes of action, damages, losses, liabilities, costs, and expenses (including attorney's fees) arising out of or relating to
